Terms and Conditions

The following are the Terms and Conditions of the Friends of the North West Air Ambulance Lottery Community Interest Company (FONWAA) for the weekly Lift off Lotto, Lottery draw. FONWAA is registered in England and Wales under Company No. 06646759 and its registered office is at North Mersey Business Centre, Woodward Road, Knowsley, Merseyside, L33 7UY.

FONWAA operates society lotteries with the sole purpose of raising funds for North West Air Ambulance (Charity no. 1075641) (NWAA). The FONWAA Lift off Lotto, lottery draw is a weekly subscription society lottery promoted by FONWAA in support of the NWAA Charity.

By entering the weekly Lift off Lotto lottery draw, entrants confirm that they accept these Terms and conditions and that they agree to be bound by them.

We recommend that each entrant should acquire and keep a copy of these Terms and Conditions for their future reference. We may amend these Terms and Conditions from time to time. Every time you wish to enter the Lift off Lotto lottery draw, please check these Terms and Conditions to ensure you understand the Terms and Conditions that apply at that time. Any changes will be published on www.nwairambulance.org.uk at least twenty-eight (28) days in advance of taking effect.

If you are not satisfied with any proposed amendments, you can cancel your Lift off Lotto lottery subscription instalment payment plan at any time in accordance with the Terms and Conditions. These Terms and Conditions were last updated on 24th July 2026.

Gambling Commission Licences

The FONWAA weekly Lift off Lotto lottery draw is operated as a series of society lotteries under the Gambling Act 2005. Friends of the NW Air Ambulance Lottery Community Interest Company is licensed and regulated in Great Britain by the Gambling Commission under account number [5227](https://www.gamblingcommission.gov.uk).

How much was returned to the good causes and what good causes they're supporting?

Lift Off Lotto

- In 2025 FONWAA received £5,790,040 ticket sales for its Lift Off Lotto lottery of which £4,678,067 (80.79%) of this figure went straight back to the charity.
- **How much was spent on prizes?**
£105,885 (1.83%) was spent on prizes for our Lift Off Lotto lottery
- **How much was spent on expenses?**

£1,006,088 (17.38%) was spent on expenses for our Lift Off Lotto lottery

- **The process around the awarding of grants?**

We don't award any grants.

- **The way in which winners are determined and prizes allocated?**

The draws are conducted using a Random Number Generator which has been tested and approved by a Gambling Commission approved test house to ensure fairness and compliance with the applicable sections of the Gambling Commission's Remote Technical Standards.

The prizes are awarded on a 100% chance basis. There are no rollovers of prizes. A Random Number Generator selects supporters who are entered into each draw to distribute the prizes.

- **What are the potential prizes available?**

- From March 20th, 2026, the weekly prizes consist of a first prize of £1,000, plus runner up prizes of one £100 prize, two £50 prizes, three £25 prizes, six £10 prizes, three £5 prizes and 50 players will receive 1 entry into the next draw.

- On the fourth Friday in September, December, March, and June each year, the top prize will be £10,000 instead of £1,000. All runner-up prizes will remain the same.

- There are no alternatives to the Prizes offered and no interest is payable.

- **What is the likelihood of winning a prize in our Lift Off Lotto lottery?**

We have approximately 118,000 plays in each draw odd of winning are 66 in 118,000 or 1 in 1,787.

Rules of Play

- To enter any FONWAA lottery you must be aged 18 plus and be a resident of Great Britain (for the avoidance of doubt, this excludes Northern Ireland, the Channel Islands, Isle of Man and BTPO addresses). It is an offence for anyone under the age of 18 to play any FONWAA lottery.
- Any person who has entered the Lottery and who is found to be under the minimum age limits set out in this paragraph will automatically forfeit any prize and their entry monies will be refunded. We reserve the right to require proof of identity and age.
- All entries are priced at £1 each for the weekly draw.
- Any entries given as prizes in the weekly draw are paid for by NWAA and no cash alternative is offered.
- Staff of NWAA and FONWAA that work in connection with our Lottery and Raffles are prohibited to play.
- Following initial registration, players will receive a 'welcome letter' by post usually within 14 working days and their ticket showing their lottery draw number(s) for each entry in the lotteries and information regarding the price of each entry, the promoter, prizes, and contact details of the responsible persons. This should be retained for future reference. If you do not receive this within 14 days of your initial registration, please contact us.
- The maximum number of entries permitted for any individual is 20 per week. This limit may vary in the event of additional single tickets being sold for superdraws where this limit will be increased to 50 entries for any individual.
- Only players who have paid for entry for the relevant week will be entered into the draw.
- Players will never accrue any debt to any NWAA Lift off Lotto Lottery.
- All lottery entry sales are final, and no refunds shall be made at any time, save as otherwise set out in these Terms and Conditions.
- Entrants acknowledge that their payment of £1 entry into the Lift Off Lotto lottery draw does not guarantee that they will win any prize.
- All entrants are solely responsible for providing FONWAA with their accurate and up-to-date contact details. In the event that an entrant changes their contact details, they will be solely responsible for advising FONWAA of such changes. FONWAA will be in no way liable for any failure or inability to contact any entrant due to errors, omissions, or inaccuracies in the contact details that the entrant has provided.
- By entering the Lift off Lotto lottery draw, you consent to us conducting anti-money laundering, age verification, and/or address checks from time to time.

- FONWAA reserves the right without notice or reason (acting reasonably at all times) to cancel or refuse entry to any lottery. Such decisions shall be final and binding. In such circumstances, relevant entries will be excluded from the applicable draw and any entry fees paid will be refunded. Other than FONWAA refunding any such entry fee amounts, FONWAA shall not (except to the extent that such liability cannot be excluded by law) be liable for any loss or damage (including the loss of the opportunity to enter the Lottery and/or chance of winning a prize) suffered by you in relation to such refusal or cancellation.

Payments

- Payment can be made by direct debit, standing order, or advanced cheque payment. No cash, debit card or credit card payments are accepted.
- Payments can be made in instalments of any of the following (based on one entry per draw) dependent on method of sign up:
 - Online sign-ups monthly Direct Debit payments of £4.34, quarterly payments of £13, half yearly payments of £26 or annual payment of £52.
 - Paper sign-ups monthly Direct Debit payments of £4.34, annual Direct Debit payment of £52 or cheques payments for £26 half yearly or £52 annually.
 - Canvasser sign up monthly Direct Debit payment of £4.34 or cheque payment for £26 half yearly or £52 annually.
- **Direct Debit payments:** must be received by FONWAA by 5pm the Thursday of the week of the draw to be included in that week's draw.
- **Standing Order payments:** must be received by FONWAA by the Wednesday of the week of the draw to be included in that week's draw.
- **Cheque payments:** must be received by FONWAA by the Thursday morning of the week of the draw to be included in that week's draw.
- No refunds can be made for entries after they have been entered into a draw.
- We are required by our licence to inform customers about what happens to funds which we hold on account for you, in the event of FONWAA insolvency. The Gambling Commission provides further information on our [licence conditions detailing what we need to tell customers about their funds1](#).
- We hold customer funds separate from company funds. These funds are not protected in the event of FONWAA insolvency, this is rated as 'not protected – segregation of customer funds' by the Gambling Commission. [For more information, please see the customer funds insolvency ratings system2](#).
- Players should note the dates and frequency of payments to ensure that funds are available to cover the agreed Direct Debit request, Standing Order or Cheque payments.
- Bounced cheques, failed Direct Debit payments, and failed Standing Order payments will not be considered valid entries.

The Draw & Prizes

- The draw will normally take place each week on a Friday. However, where it becomes necessary to do so, due to Bank Holidays or unforeseen circumstances, we reserve the right to change the day of the draw to take place on the nearest possible working day. Any changes will be posted on our website.
- In each draw the winning player draw numbers will be selected at random by a Gambling Commission approved Random Number Generator at the offices of our External Lottery Manager, Sterling Management Centre Limited. Sterling is licensed and regulated in Great Britain by the Gambling Commission under account number [3137](#).
- Winners will be announced on the day of the draw on the NWAA website <http://www.nwairambulance.org.uk/play-our-lottery>.

- Only the winning numbers and general location of the player will appear on these pages, no names will be displayed. A full list of winners is also available in writing on request from the NWAA Head Office. You have a right to object to the announcement of personal data. Please contact us should you wish to object to this at <http://www.nwairambulance.org.uk/contact>. However, ticket numbers must be published in line with our regulatory requirements, and we must still provide the information and winning entries where it is required to do so by law, the Gambling Commission, or the Advertising Standards Authority on request.
- Top prize winners may be asked to take part in promotional activity. Any participation entered into will be entirely at the discretion of the individual.
- Guaranteed prizes in each draw are: £1,000, £100, 2X £50, 3X£25, 6X£10, 3X£5 and 50X1 entries into the next draw for our weekly Lift Off Lotto lottery.
- On the fourth Friday in September, December, March, and June each year, the top prize will be £10,000 instead of £1,000. All runner-up prizes will remain the same. All active Lift Off Lotto lottery players will be entered into this draw at no extra cost to the player. We may from time to time offer the opportunity to purchase single tickets for these draws as either additional entries or standalone tickets. This will be advertised on our website; will be purchasable online and additional tickets may also be posted out.
- There is no need to contact us to make a claim. If you are successful, then your prize will be automatically issued. A cheque will be made payable in the name of the entrant and posted to the winner's registered address as soon as is reasonably possible following the completion of the draw up to maximum of 15 working days after the date that the relevant Lottery draw has been drawn.
- Main prize winners will be contacted by telephone and in writing.
- Reasonable effort will be made to contact the winners. In cases where the player contact information provided is out of date, incorrect or insufficient and we have been unable to contact the player then these will be treated as unclaimed prizes after a period of twelve months.
- Any unclaimed prizes, or prize cheques not cashed after a period of four months FONWAA will make reasonable effort to contact, and after twelve months will be deemed to be and be treated as if it were a donation to the NWAA if still unclaimed.
- FONWAA reserves the right to withhold payment of a prize if they are not satisfied as to the validity or legality of a player. An investigation will be entered into in each case and a decision on payment will be made in accordance with the outcome of the investigation.
- Lift off Lotto Lottery subscriptions can be cancelled at any time by notifying FONWAA in writing, by phone or via email. Please visit the FAQ's section on for details. If credit remains after cancellation, entries into the draw will continue until the credit is below the value of £1. Any further remaining balance below the value of £1 which does not qualify for draw entry will be treated as a donation to NWAA. A player may claim a refund for balances under £1 up to twelve months after cancellation.
- If a player is deceased any remaining credit will be entered into the draw until it expires and any winnings during this time will be made payable to the deceased's estate. Any monies that remain unused upon notification will be refunded to the deceased's estate if desired. This can either be accepted or treated as an unclaimed prize, as set out above.

Data protection

- FONWAA are committed to protecting your privacy. Data that is collected, stored, and processed for the purposes of the weekly Lift off Lotto lottery draw is subject to the terms of NWAA's privacy policy. - You agree that pursuant to our obligations under the Gambling Act 2005, we may process your personal data for the purposes of Age Verification.

Liability

- FONWAA, its agents or distributors shall not (except to the extent that such liability cannot be excluded by law) in any circumstances be responsible or liable for any loss or damage suffered by you in relation to your participation in the Lottery (including the loss of the opportunity to enter the Lottery and/or chance of winning a prize) if you have not complied with these Terms and Conditions.
- FONWAA, its agents or distributors will not be liable (except to the extent that such liability cannot be excluded by law) to any player for loss or damage arising from:
 - i. Any delays or failures in the postal service or delivery methods used by FONWAA.
 - ii. Any delays or failures in software used by FONWAA.
 - iii. Any delays or failures in the banking system used by FONWAA or the player.
 - iv. Any refusal by FONWAA to accept registration of a player or the cancellation of a player.
 - v. Any failure to enter a chance into the lottery draw.
 - vi. Any event beyond the reasonable control of FONWAA.

Responsible Gambling
